Young Henrys and Swiss 8 will contact prize winners to determine date and time of prize receivership.

Major prizes will be forfeit after the 04 of August 2021.

A week by this definition is one calendar week, Monday to Sunday.

Prizing must be claimed within the week after the draw. Prizing is defined as finite, and excess or unallocated prizing cannot be rolled over or stored as credit.

In the event that for any reason whatsoever a winner does not take an element of the prize in the time stipulated by the Promoter then that element of the prize will be forfeited by the winner and no alternative prize will be awarded in lieu of that element of the prize.

Redemption of all prizes commences on 4 June, 2021 and continues for two months after, expiring on 4 August 2021.

The Promoter reserves the right to extend delivery dates of prizing in the event of supply or availability of product.

Prize winners must provide a valid address for prize delivery.

Prize winners must ensure trailer access to the property.

The promoter reserves the right to deny delivery to a recipient and co-recipients private address for the duration.

The Promoter reserves the right to allocate prizing as cash.

The Promoter will make every effort to make each prize COVID safe in compliance with Australian Government mandates.

In case of late cancellation and/or amendment (within 48 hours of agreed prize activity) the Promoter reserves the right to charge winners and/or participants any cancellation and/or amendment fees covering transport.

Maximum Entries per person

The minimum number of tickets to enter the raffle is one (1).

Entries are allocated in ticket lots of one (1), three (3), ten (10), twenty five (25) per transaction.

A person may purchase tickets in lots, in which case, each lot will have allocated individual ticket numbers. These tickets may be sequentially allocated or randomly allocated. This allocation is ticket numbering only and does not impact or alter the outcome of the draw.

For each draw a unique ticket will be randomly selected. This ticket once selected will be deemed void, and not placed back into the draw for subsequent prizing. The winner does not have to be present at the draw to win.
